

## Nemaha County Board Minutes



County Board of Commissioners of the County of Nemaha, State of Nebraska met on March 27, 2013, Commissioner's Chambers, Nemaha County Courthouse, Auburn NE for a regular scheduled meeting. Notice of meeting published in the Nemaha County Herald on March 21, 2013. The agenda for the meeting was kept continually current and available for public inspection at the office of Nemaha County Clerk during normal business hours and also on the Nemaha County website. The agenda was held open until one business day prior to the meeting for appearance before the board and items for approval by the Board of Commissioners. The Board of Commissioners has the right to modify the agenda to include items of an emergency nature only at such public meeting.

Chairman Hutton called the meeting to order at 8:01 a.m. Present for the meeting: Commissioner District 1 Bob Hutton, Commissioner District 2 Dennis Wittmann, Commissioner District 3 Marvin Bohling and County Clerk Joyce Oakley.

Chairman Hutton led the Pledged of Allegiance.

Chairman Hutton noted the posting of the Open Meeting Poster and the availability of the Open Meeting Handouts to the public.



Richard Andrew was present to represent Bryce Andrew regarding working on county road 724A located in Section 10 T4N R15E to the Nemaha river. Board will contact Mainelli Wagner & Associates for advice on updating the road.

Public Notice for receiving sealed bids for lawn care service/sprinkler system for courthouse and jail lawns was advertised in the Nemaha County Herald on March 14, 2013 and March 21, 2013. The following sealed bids were publicly opened in the presence of the bidders: American Lawncare: Courthouse - 4 Step Program \$1,400.00, 5 Step Program \$1,750.00, 2 treatments for Jail \$75.00 per application, sprinkler service repair \$40.00 per hour + parts; Green Care Lawn Service: Courthouse - \$192.00 per application, Jail - \$62.00 per application, sprinkler service repair \$45.00 per hour plus parts. Motion by Hutton, seconded by Wittmann to table the awarding of the sealed bids for the lawn care service/sprinkler systems for the courthouse and jail lawns until more information on the quantity and the chemicals to be used for each application is provided by the bidders. Marie Martin, Nemaha County Support Enforcement Officer for Nemaha County updated the board on the self assessment audit conducted by the State of Nebraska for selected counties. Marie explained that the State conducts their own audit prior to the federal audit and she explained to the Board that Nemaha County's audit of the child support records was excellent. The audit was conducted on 15 random pulled cases for a 2 year period.

County Attorney Louie Ligouri visited with the board regarding a legal opinion of granting or denying on the petition of granting or denying an access road to Lot 1 of 5 & Lot 5 in Section 15 T5N R14E requested by Michael Ely. Board will take action at their Board of Commissioners meeting on April 10, 2013.

The following fuel bids for April, 2013 were received: Lueders Petroleum No. 2 Diesel \$3.595, Unleaded \$3.475; Farmers Coop No. 2 Diesel \$3.566, Unleaded \$3.451. Motion by Wittmann, seconded by Bohling to approve Permit 2013-04 Under Crossing of County Road Right of Way requested by Windstream Communications, to replace buried cable appx. 2700 ft east of Hwy 105 on 724 Road in the SE <sup>1</sup>/<sub>4</sub> of Section 7 T4N R13E. Motion by Bohling, seconded by Wittmann to adopt Resolution 2013-15, changing the classification of county road 2,640 ft S of the NE corner of Section 5 T4NR14E also known as 644 Avenue from minimum maintenance to local. Roll call vote: Hutton, aye; Wittmann, aye; Bohling, aye.


