



County Board of Commissioners of the County of Nemaha, State of Nebraska met on October 23, 2013, Commissioner's Chambers, Nemaha County Courthouse, Auburn NE for a regular scheduled meeting. Notice of meeting published is published weekly in the Nemaha County Herald. The agenda for the meeting was kept continually current and available for public inspection at the office of Nemaha County Clerk during normal business hours and also on the Nemaha County website. The agenda was held open until one business day prior to the meeting for appearance before the board and items for approval by the Board of Commissioners. The Board of Commissioners has the right to modify the agenda to include items of an emergency nature only at such public meeting.

Chairman Hutton called the meeting to order at 8:04 a.m. Present for the meeting: Commissioner District 1 Bob Hutton, Commissioner District 2 Dennis Wittmann, Commissioner District 3 Marvin Bohling and County Clerk Joyce Oakley.

Chairman Hutton led the Pledge of Allegiance.

Chairman Hutton noted the posting of the Open Meeting Poster and the availability of the Open Meeting Handouts to the public.

Motion by Wittmann, seconded by Bohling to approve the agenda as presented. Roll call vote: Hutton, aye; Wittmann, aye; Bohling, aye.

Motion by Wittmann, seconded by Hutton to amend the agenda to add: #3 Buildings/Grounds/Property/Equipment/Office Equipment/Furniture: Approval of informal quotes for Backhoe Loader, as advertised, Nebr. State Statutes §23-3109(3). Roll call vote: Bohling, aye; Wittmann, aye; Hutton aye.

Motion by Bohling, seconded by Wittmann to approve the October 9, 2013 regular scheduled meeting minutes with no corrections. Roll call vote: Wittmann, aye; Bohling, aye; Hutton, aye.

Motion by Bohling, seconded by Wittmann to approve the accounts payable claims as presented by the County Clerk and authorized for payment by the Board of Commissioners. Roll call vote: Bohling, aye; Hutton, aye; Wittmann, aye.

Board sine die at 8:17 a.m. to meet as Board of Equalization. Board reconvened at 8:23 a.m. to meet as Board of Commissioners.

Sasha Rightsell presented her quarterly report for SENCA, noting the current activities of SENCA.

Larry Miller and Adam Greenquist representatives of Nebraska Machinery Co. and Luke Winkelman were present to discuss the future purchase of a tractor backhoe. Winkelman asked why the backhoe was needed. He also indicated the Board of Public Works is willing to cost share their backhoe in exchange of the BOPWs needing to use a lowboy trailer. Wittmann indicated he talked to the BOPW and they would rent their backhoe for \$45.00 per hour to the county through an interlocal agreement. The BOPW have since indicated they would exchange costs of their backhoe for use of our lowboy trailer.

Blake Zinn, representative from Northwestern Mutual was present to discuss offering additional retirement options to Nemaha County employees. Board gave him permission to visit with the employees.
