



Nemaha Board of Equalization Minutes



Board of Equalization of the County of Nemaha, State of Nebraska met on December 10, 2013 Commissioners Chambers, Nemaha County Courthouse, Auburn NE. Notice of meeting published in the Nemaha County Herald on 2013. The agenda for the meeting was kept continually current and available for public inspection at the office of Nemaha County Clerk during normal business hours and also on the Nemaha County website (www.nemahacounty.ne.gov). Assessor Smith presented tax list correction #1312-02, parcel 640098258, Beverly J. Gilbertson, sold mobile home to James O. Smith in 2012, acceleration of taxes, \$219.98 deducted tax. Motion by Bohling, seconded by Hutton to approve tax list correction for Beverly J. Gilbertson in the amount of \$ 219.98 deducted tax. Roll call vote: Wittmann, aye; Bohling, aye; Hutton, aye.
